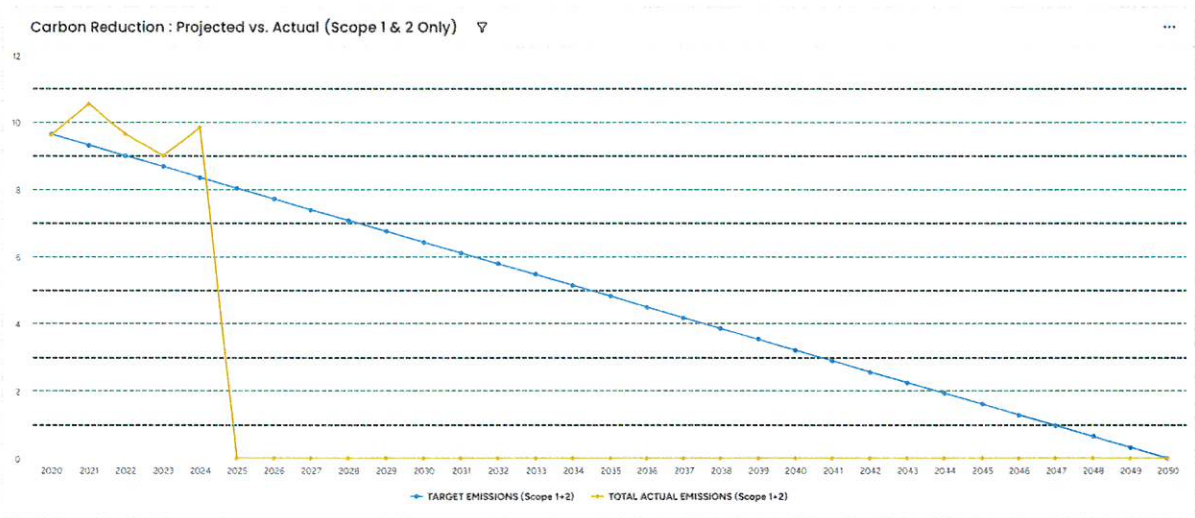
# Emissions reduction targets

To continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

- Our ambition is to become carbon negative by 2050
- We are committed to following the Science Based Targets initiative and have proposed the following targets:

We project that carbon emissions will decrease over the next five years to 7.08 tCO<sub>2</sub>e by 2028. This is a reduction of 26.63% since baseline year 2020 (for Scope 1 & 2 only)

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2020 baseline.

- Introduction of LED lighting
- Introduction and use of renewable electricity tariff
- Reduction in travel for commuting
- Introduced certification to ISO 14001
- Reduction in business travel/flights

The carbon emission reduction achieved by these schemes equate to 1tCO<sub>2</sub>e, a 3% reduction against the 2020 baseline and the measures will be in effect when performing the contract.

### Future Carbon Reduction Plans

In the future we will and hope to implement further measures such as:

- To thoroughly examine Scope 3 emissions and use the data to set the targets and goals for the wider footprint.
- Reduction in use of fuels used in fleet vehicles
- Change of fuels to produce less carbon emissions
- Move to electrification of fleet in due course

### Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard<sup>1</sup> and uses the appropriate Government emission conversion factors for greenhouse gas company reporting<sup>2</sup>.

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard<sup>3</sup>.
